Abstract

Abstract

This working paper provides a detailed overview of the trade in wood-based or wood-containing products¹ in the EU27 in 2020 and distinguishes products already under the scope of the EUTR and the proposed regulation of the European Commission on deforestation-free value chains, from products not in the scope of those two regulations.

The study considers overall 769 products (according to the 8-digit product codes of the Combined Nomenclature) from the entire list of goods for international trade statistics, provided that some wood content can be assumed. Of these products, 348 are already in the scope of the EUTR. The remaining 421 products are considered, to assess their relevance in EU27 wood-based products trade. Therefore, trade values and quantities for each product are taken from EUROSTAT foreign trade data bases. To compare the wood content related to each product, trade quantities were converted into trade volumes of cubic meters of roundwood equivalents (RWE m³). The roundwood equivalent indicates how much raw wood is required to produce the respective wood-based product. Converting the trade volumes into this physical reference value also enables a raw material-related comparison of the traded products.

The working paper presents three different trade flows, which all fall within the scope of the proposed new regulation for deforestation-free products: a) Imports of wood-based products from third countries into the EU27, b) exports to third countries from the EU27, and c) intra trade within the EU27 internal market (between EU Member States).

Further, detailed information on data compilation, data gaps and uncertainties and conversion factors applied are given within this working paper.

Table 1 shows the aggregated results of trade volumes (in RWE m³) for imports, exports and intra trade with wood-based products. Products within the EUTR-scope are differentiated from those out of EUTR-scope.

The table shows, that in 2020 approximately 87 % of wood-based commodity imports from third countries into the EU27 have been covered by the EUTR. This scope of imported products is also envisaged to be included under

the new regulation proposal for deforestation-free value chains (see green shading in Table 1). Other than the EUTR, the new regulation proposal for deforestation-free value chains intends to broaden the scope (and the due diligence requirement for enterprises) from imports only (placing on the EU internal market²) to exports, as well as to trade within the EU³ (red shading). The second result row of the table summarizes the trade of wood-based products that are not covered by the EUTR so far. Discussions are currently taking place within the EU as to whether some of these products should be included in the new proposed regulation on deforestation-free value chains.

The largest commodity groups by volume (RWE m³) not covered by the EUTR are:

- Recovered paper (part of CN 47)
- Other articles made of wood (part of CN 44), especially charcoal
- Furniture (part of CN 94), especially chairs
- Printed media (CN 49)

Zusammenfassung iii

Zusammenfassung

Dieses Arbeitspapier gibt einen detaillierten Überblick über den Handel mit holzbasierten und Holz enthaltenden⁴ Produkten in der EU27 im Jahr 2020 und unterscheidet zwischen Produkten, die bereits in den Anwendungsbereich der EUTR sowie der vorgeschlagenen Verordnung der Europäischen Kommission über entwaldungsfreie Lieferketten fallen, und Produkten, die nicht unter einen dieser beiden Anwendungsbereiche fallen.

Die Studie betrachtet insgesamt 769 Produkte (nach den 8-stelligen Warennummern) aus dem gesamten Warenverzeichnis für die Außenhandelsstatistik, sofern ein gewisser Holzanteil angenommen werden kann. Davon fallen 348 Warennummern bereits in den Geltungsbereich der EUTR. Die weiteren 421 Produkte wurden betrachtet, um ihre Bedeutung für den holzbasierten Produkthandel der EU27 zu bewerten. Dazu wurden die Handelswerte und -mengen für jedes Produkt aus den Außenhandelsdatenbanken von EUROSTAT entnommen. Um den Holzanteil der einzelnen Produkte zu vergleichen, wurden die Handelsmengen in Kubikmeter Rohholzäquivalente (RWE m³) umgerechnet. Das Rohholzäquivalent gibt an wieviel Rohholz für die Herstellung des holzbasierten Produkts erforderlich ist. Die Umrechnung der Handelsvolumen in diese physische Referenzgröße ermöglicht zudem einen rohstoffbezogenen Vergleich der gehandelten Produkte.

Das Arbeitspapier stellt drei verschiedene Handelsströme vor, die alle in den Anwendungsbereich der vorgeschlagenen neuen Verordnung für entwaldungsfreie Lieferketten fallen: a) Importe von holzbasierten Produkten aus Drittländern in die EU27, b) Exporte in Drittländer aus der EU27 und c) Intrahandel innerhalb des EU27-Binnenmarktes (zwischen EU-Mitgliedstaaten). Weitere detaillierte Informationen über die Datenerstellung, Datenlücken und -unsicherheiten, sowie die verwendeten Umrechnungsfaktoren sind in diesem Arbeitspapier enthalten.

Table 2 zeigt die aggregierten Ergebnisse des Handelsvolumens (in RWE m³) für Importe, Exporte und den Intrahandel mit holzbasierten Produkten. Dabei wird zwischen Produkten, die unter die EUTR fallen, und solchen, die nicht unter die EUTR fallen, unterschieden.

iv Zusammenfassung

Die Tabelle zeigt, dass im Jahr 2020 etwa 87 % der Importe von holzbasierten Produkten aus Drittländern in die EU27 von der EUTR erfasst wurden. Dieser Anteil der eingeführten Produkte soll auch in den neuen Verordnungsvorschlag über entwaldungsfreie Lieferketten einbezogen werden (siehe grüne Schattierung in Table 2). Im Gegensatz zur EUTR soll der Anwendungsbereich (und die Sorgfaltspflicht der Unternehmen) mit dem neuen Verordnungsvorschlag von der hauptsächlichen Betrachtung der Einfuhren (Inverkehrbringen auf dem EU-Binnenmarkt⁵) auf Ausfuhren sowie auf den Handel innerhalb der EU⁶ ausgeweitet werden (rot schraffiert). In der zweiten Ergebniszeile der Tabelle ist der Handel von Waren zusammengefasst, die bislang nicht von der EUTR abgedeckt sind. Derzeit wird innerhalb der EU diskutiert, ob einige dieser Waren in den neuen Verordnungsvorschlag über entwaldungsfreie Lieferketten aufgenommen werden sollen. Der Arbeitsbericht listet dazu detailliert die Handelsströme der einzelnen Produktgruppen (nach 4-stellingen Warennummern) in Euro, Kilogramm und Rohholzäquivalenten auf.

Die größten, durch die EUTR nicht berücksichtigten Produktgruppen nach Volumen (RWE m³) sind:

- Altpapier (Teil von CN 47)
- Möbel (Teil von CN 94), insbesondere Stühle
- Andere Artikel aus Holz (Teil von CN 44), insbesondere Holzkohle
- Bedruckte Medien (CN 49)

Introduction 1

1 Introduction

The European Timber Regulation (EUTR) (Regulation (EU) 995/2010) regulates the import and trade of certain wood-based products in the European Union. The EUTR prohibits the placing of pertinent products from illegal sources on the EU market and requires market operators to exercise due diligence when placing pertinent products on the EU market. Not all wood-based or wood-containing products⁷ are, however, covered by the EUTR. Wood-based products in the scope of the EUTR are listed in its Annex I.

In 2021, the European Commission (COM) proposed a new regulation for managing the import and trade with commodities such as soy, cattle, coffee, cocoa, palm oil as well as wood. The aim of the regulation proposal is to stop the trade with commodities that cause deforestation, forest degradation or that stem from illegal sources. The draft of the regulation was published 17.11.2021, and is called "*Proposal for a Regulation of the European Parliament and of the Council on the making available on the Union market and export from the Union of certain commodities and products associated with deforestation and forest degradation and repealing Regulation (EU) No 995/2010*" (see COM, 2021). The proposed regulation is supposed to replace the EUTR, once entering into force. While the regulation proposal is currently under political negotiations, the first draft by the European Commission took over the product annex of the EUTR for regulating trade with wood-based products.

However, an extension of the product annex for wood-based products is already being discussed within the framework of the EUTR and also in the course of negotiations on the new regulation proposal. On 24.06.2022, a general approach of the Council of the European Union (see EU Council, 2022) was presented by the Council Presidency as a compromise text to the Commission's regulation proposal. Further, the European Parliament adopted an amendment to the EU Commission's regulation proposal on 13.09.2022 (see EP, 2022). Both compromise drafts proposed adding more wood-based products than included under the EUTR to the product scope of the upcoming regulation. When deciding on the inclusion of products in the regulatory framework, the question is, which products have a relevant wood content and account for a relevant market share of the EU trade in wood-based products.

This working paper therefore considers all products for which some wood content can be assumed. For each product, the respective trade volumes are converted into the reference unit cubic meters of roundwood equivalents (RWE m³). This reference unit estimates the roundwood input required for the production of the respective products. The study provides a detailed overview of the wood-based products trade of the EU27 in 2020. No such up to date and comprehensive overview exists so far. The latest comprehensive overview of wood-based product imports to the EU was published in 2019 by an impact assessment study commissioned by the European Commission (EC, 2019: "Impact Assessment Study for the Revision of the Product Scope of the EU Timber Regulation"). This study is based on data from 2011-2015 and neglects certain products due to missing conversion factors for roundwood equivalents.

The present study is based on EUROSTAT data and considers trade in wood-based and wood-containing products of the year 2020 that are within the *EUTR-scope* and outside the EUTR scope of application (*out of EUTR-scope*). It considers overall 769 products on 8-digit level of the Combined Nomenclature (CN).

Three different trade flows are presented in this working paper, as they fall within the scope of application of the proposed new regulation for deforestation-free products: a) Imports of wood-based products from third countries⁸ into the EU27, b) exports to third countries from the EU27, and c) intra trade within the EU27 internal market (between EU Member States).

A list of wood-based products was assembled (see Chapter 2.1) for which respective trade data for the year 2020 was compiled. A differentiation in products within the EUTR scope and those out of the current EUTR-scope was conducted. This differentiation was done using the 8-digit codes of the Combined Nomenclature (CN) (see Chapter 2.2). EUROSTAT international trade data for 2020 (Eurostat, 2020) were used to obtain trade values and weights as basis for the calculations. The data reported in the statistics for imports and exports are not always congruent. The data used here are based on import data. The EUROSTAT trade database covers bilateral trade of all EU27 countries. In trade statistics products are generally reported in net mass of traded quantities and in monetary values. For the data presentation all information are unified to trade values in euros and trade weights in kg. Further, for better interpretation of the relevance of trade of wood-based and wood-containing products, data are converted to trade volumes in the reference unit cubic meters of roundwood equivalent (RWE m³) (see Chapter 2.3).

The data refer to the EU27 countries. All other countries are designated as third countries. However, the EUROSTAT data still include values for the United Kingdom for January 2020. We did not correct the original data for this deviation.

The data presentation is differentiated in imported products from third countries to the EU27 (Chapter 3.1), exported products from the EU27 to third countries (Chapter 3.2) and products traded within the EU27 internal market (Chapter 3.3). The present working paper covers international trade only and does not include data on domestic trade within the national markets of individual EU Member States.

Both regulations (the EUTR and the proposed regulation on deforestation-free value chains) pose due diligence requirements on EU operators and traders. The regulatory targets (affected enterprises and trade flows) however differ (see Table 3).

As Table 3 shows, the due diligence requirements of the EUTR comprise operators that place products on the EU internal market for the first time. This relates to enterprises that import pertinent products from outside the EU as well as to domestic producers of timber, who place pertinent products on the EU internal market. Under the EUTR, traders within the EU are not obliged to perform the due diligence requirements. The new regulation proposal affects a wider range of enterprises. It imposes due diligence obligations not only on the first placing of wood-based products on the EU market, but also on enterprises exporting from the EU to third countries (also

called operators), and on enterprises trading products within the EU (called traders). As Table 3 shows, this trading activity might be related to intra trade between EU Member States, but also to trade within the domestic market of single EU Member States. Further, the due diligence requirements shall only apply to traders who are not small and medium enterprises (SMEs).

It is not possible to reproduce all these cases on the basis of the trade data (see Table 3). The assignment of trade activities to enterprise sizes is not possible based on the data. Thus, trade flows for intra trade, as presented in this working paper, also include trade activities performed by SMEs. Domestic trade originating from timber harvesting within the EU or due to trading activities within an EU MS is not included in this study.

2.1 Included commodity groups and products

In this study, all products falling within the scope of the EUTR (hereinafter called *EUTR-scope*) were considered. Therefore, the Annex I of the EUTR (EU-VO 995/2010 Annex I) is taken as a basis. Other products that may also contain wood (hereinafter called *out of EUTR-scope*) were distinguished from these. The products falling within the scope of the first proposal of the regulation on deforestation-free value chains equal those listed in Annex I of the EUTR.

For the estimation of wood-based products out of EUTR-scope, all commodity codes considered in the EC impact assessment study (EC, 2019) were applied. In addition to the products considered in EC (2019), products under CN chapters 56 and 59 which contain viscose were considered. As the present study was able to apply conversion factors for more products as compared to EC (2019), the calculated totals for the volumes of commodity groups differ from those presented in the EC (2019) study.

In total 769 products (CN-codes at the 8-digit level) were included. All included products are listed in the Annex of this working paper. The main data tables in Chapter 3 *Results* aggregate the data on 4-digit level and provide subtotals for the related chapters (2-digit level).

2.2 Application of the Combined Nomenclature (CN) – update and comparison of CN codes

The wood-based commodity groups and products considered are subdivided according to the trade classification of the Combined Nomenclature (CN) as of 2020. The CN is used to classify goods and meet the requirements of the Common Customs Tariff and of the EU's external trade statistics (see also EC, 2022). It is applied when goods are declared to customs in the EU.

The CN describes the commodity chapter at the 2-digit level. Contained commodity groups and products under each chapter are further specified by 4-, 6- and 8-digit codes. The latter represents the highest level of detail of the CN.

The CN identifiers are updated annually. Thus, codes from the year 2010 when the EUTR was adopted and today might have changed. We updated the CN codes listed in the product annex of the EUTR and the new regulation proposal to the CN status of the years 2020 and 2022. The most recent comprehensive trade data is available for the year 2020. However, actual discussions of the proposal should use the actual CN codes from 2022. Hence, we applied trade data from 2020 as well as CN codes of 2022 in this report. Table 4 shows a comparison of the CN codes listed in the EUTR and those of 2020. Further, the table shows a comparison to the latest CN codes of 2022, as the new regulation proposal is supposed to base on the most actual version of the CN.

Please note that codes 961900xx listed under CN 2020 and CN 2022, have not been considered products in EUTR-scope in this working paper. These codes contain partly EUTR-products formerly coded as 481840xx. However, the new codes also include other products which are out of the EUTR-scope.

The presentation of the data in Chapter 3 is sorted according to the 2-digit chapters. Under each chapter, all eligible (wood-containing) commodity groups are listed at the 4-digit level. It should be noted that not all commodity groups contained under a chapter contain wood components. Accordingly, only the affected 4-digit categories have been listed here. All aggregated 4-digit categories are composed of various products at 8-digit level. The products at 8-digit level are listed in the Annex of this working paper and are not separated in the main tables. All values given for a commodity group at the 4-digit level sum up accordingly only those products at the 8-digit level that contain wood. A finer division into 6-digit or 8-digit codes was reported in the main tables only when necessary to distinguish EUTR from non-EUTR products.

2.3 Calculation of wood content and conversion in roundwood equivalents

For the analyzed products, trade values (in €) and trade quantities (in kg) were retrieved from EUROSTAT databases. These measures, however, do not suffice to compare the products related to their wood content. Several products contain other materials or even only contain small portions of wood or wood fibers, related to their total mass. Therefore, all trade volumes were converted into cubic meters of roundwood equivalents (RWE m³). Roundwood equivalent is a theoretical reference unit that indicates how much roundwood would be required for the production of a unit of a respective wood-based or wood-containing product, taking yield losses into account (see also Weimar, 2020; Weimar et al., 2015).

Conversion factors are applied for each product at the 8-digit level (all conversion factors applied for this working paper are reported in the Annex). The reported RWE conversion factors were applied to the traded quantities in kg for most products. Only for products falling under CN code 4403, the conversion factors were applied to the trade quantities reported in a supplementary unit by EUROSTAT.

When available, conversion factors were used from the internal database of the Thünen Institute of Forestry (TI WF, 2022). Missing data was supplemented with conversion factors taken from literature, approved and where necessary adapted by expert judgement. For a total of 447 products, conversion factors from the TI WF (2022) internal database were applied. The internal database contains conversion factors for all wood-based products regularly reported in wood balance statistics (e.g. Weimar, 2020). These products can be referred to as classical wood-based products. However, plenty other products contain portions of wood or wood fibers, or can sometimes be made from wood (e.g., toys), but are not always. For these products the wood content contained in the traded quantities is often subject to great uncertainties. If conversion factors from the internal database were not available for a product, conversion factors from the literature were considered. As a first data source, estimates reported in EC (2019) were considered. EC (2019) reports conversion factors from diverse data sources, as well as from expert judgement. For products with uncertain wood content, EC (2019) transferred conversion factors from alike products. Further, they report estimates from different sources about the assumed wood content of individual products in rough categories. These wood content categories are distinguished in: high and medium wood content, negligible wood content, may contain wood, or low wood content. For each of these categories a range of low, medium and high estimates is given. EC (2019) combines these wood content categories with conversion factors from literature or comparable products when wood content is uncertain. However, the range of estimates provided by EC (2019) is large, e.g., it ranges from 1 % to 20 % wood content for products that are identified as "may contain wood". If such a product is traded in large quantities, this range of estimates influences significantly the result. Further, the basis for the estimates is not always comprehensible and consistent from this report. We thus reviewed the reported factors for each individual product.

We checked the conversion factors and wood content categories given in EC (2019) for each product (at 8-digit level) for plausibility and, where necessary, adjusted them based on our own expert judgement. In case of ambiguity, we sought the expertise of experts in the respective fields. During this review procedure we also harmonized the estimates among each other. For instance, did we harmonize the assumption that several bamboo products may contain a "negligible wood content". In this step, we also supplemented data based on our knowledge for products with completely missing information, such as for new product classifications. Where

uncertainties remained, we applied conservative estimates. For products where a wood content classification of negligible wood content, may contain wood, low wood content, or high to medium wood content was assigned (based on EC 2019 and own expert judgement), we assumed that respectively only 5 %, 10 %, 25 %, or 100 % of the traded quantities of the product contain wood. These shares refer to the mean estimates as reported in EC (2019). This wood content category is applied to the trade weight of a product, to estimate the share of this products weight that might contain wood. To this share of trade quantity, the respective RWE conversion factors are applied subsequently.

Further, the data sources and estimates provided by EC (2019) refer to older CN classification of products, mainly 2016 and 2017. As the product classification changes annually, it is not permissible to transfer the conversion factors to more recent CN classifications without approval. The underlying reason is that products are not only assigned new CN-codes during these updates, but that a product might be divided into several new codes, and that several products (or parts of them) might be merged into aggregated new product codes. We thus approved each CN code update by own expert judgement, to assure that the application of a conversion factor and wood content estimate based on older data is still valid/ transferable to the new product classification.

The conversion factors, wood content estimates as well as the applied data sources (TI WF, 2022; EC, 2019 original data, or own expert judgement) are reported in the Annex of this working paper for each product at the 8-digit level.

3 Results

The following presentation of the results displays trade of wood-based products in €, kg and RWE m³. All trade flows are subdivided in those covering products under EUTR-scope and those with products out of EUTR-scope. The following three subchapters present different trade flows: imported products from third countries to the EU27 (Chapter 3.1), exported products from the EU27 to third countries (Chapter 3.2) and products traded within the EU27 internal market (Chapter 3.3).

3.1 Imports of wood-based products from third countries into the EU27 in 2020

The following two tables show imports of wood-based products from third countries into the EU27 in 2020. Table 5 lists all wood-based products within the *EUTR-scope*, Table 6 lists all wood-based products *out of EUTR-scope*. The tables are sorted by commodity chapters (2-digit level) and list the commodity headings included therein at 4-digit level. A higher level of precision (6-digit or 8-digit level) is only given where a distinction at this level of detail was warranted because, for example, only individual products are subject to the EUTR. For each item, the information is given as import value, import weight and import volume. For some commodity groups and products, the import volume is not given, as these positions do not contain any or only negligible contents of wood (RWE m³ value is zero) or no conversion factors were available (RWE m³ value is empty). The details for missing values are given in the Annex to this working paper.

3.2 Exports of wood-based products from the EU27 to third countries in 2020

This chapter lists the exports of wood-based products to third countries from the EU27 in the year 2020. In order to provide a simple overview of the traded quantities and values, all products are aggregated to the 2-digit level. 3.3 Intra trade of wood-based products in the EU27 internal market in 2020

This chapter lists the trade in wood-based products between EU Member States (intra-EU trade). As in chapter 3.2, all products are aggregated to the 2-digit level. The assumptions apply accordingly. Table 9 presents trade with wood-based products within the EUTR-scope, Table 10 presents trade with wood-based products out of EUTR-scope.

3.4 Main commodity groups not covered by the EUTR, proposed adjustments of the product scope and overall coverage of the EUTR

Table 11 lists the commodity groups and products on 2-digit level with the largest import volumes (calculated in RWE m³) to the EU27 in 2020. Only products that are not subject to the scope of application of the EUTR (according to Table 6) are considered. Listed are the commodity chapters that have had an import volume into the EU27 of more than 1 million RWE m³ in 2020.

Table 11 shows that the largest commodity group not (fully) covered by the EUTR belongs to chapter 47. Under this chapter, mainly "recycled products" (recovered paper) from CN group 4707 have not been covered by the EUTR. Also, chapter 44 "wood and articles of wood" contains articles not covered by the EUTR. Imports of more than 7 million RWE m³ from this chapter are outside the scope of the EUTR. "Wood charcoal" (CN code 4402), but also the collective group of "other articles of wood" (CN code 4421) are the main commodity groups in this chapter. Chapter 94 "Furniture" also shows a large quantity of over 1.8 million RWE m³ not covered by the EUTR. The highest import volume in this chapter can be attributed to "chairs" (CN code 9401). Also, with more than 1 million RWE m³ not covered by the EUTR are printed media under Chapter 49.

The European Parliament as well as the Council of the European Union proposed a product scope for the upcoming deforestation-free regulation which deviates from the proposal of the European Commission. All three proposals include the product scope as defined by the EUTR. The European Parliament (see EP, 2022) suggest to supplement the product scope by wood charcoal (CN-code 4402) and printed media (chapter 49) (see Table 12). The Council of the European Union (see EU Council, 2022) suggests to supplement the product scope by products falling under chapter 44, as well as by seats (CN-code 9401) (see Table 13).

Imports of wood-based products from third countries to the EU27 in 2020 made up a volume of 152.7 million RWE m³ in total (sum of tables 5 and 6). Table 14 shows that the current EUTR-scope covers about 87 % of all wood-based products (measured in RWE m³). The EUTR product scope is identical to the European Commission's proposal (COM, 2021). The suggested adjustment of the product scope by EU Council (2022) would increase this coverage to 93 %, while the suggested product scope by the European Parliament (EP, 2022) would cover 89 % of imports of wood-based products.

4 Discussion of assumptions and uncertainties

This report estimates the volumes of roundwood equivalents of wood-based products already included under the EUTR, compared to the volumes of wood-based products not yet covered. It assesses 769 individual products and comprehensibly reports the applied conversion factors as well as data gaps and uncertainties. In the Annex of this report, detailed information on conversion factors, data sources, or other exceptions and assumptions are provided for each included product (at the 8-digit level).

Coverage of the scope of the regulation on deforestation free value chains

The working paper considers all three trade flows which fall within the scope of application of the proposed new regulation for deforestation-free products: a) Imports of wood-based products from third countries into the EU27, b) exports to third countries from the EU27, and c) intra trade within the EU27 internal market (between EU Member States). However, the regulation proposal envisages to also put a due diligence requirement on trade activities within each Member State (domestic trade). Domestic trade is not included in this report due to missing data. Further, the regulation proposal envisages to differentiate the due diligence requirements among big and small and medium enterprises (SMEs) for intra trade activities. This differentiation of trading activities by enterprise size is also not possible on the basis of the data. Therefore, the trading values, quantities and volumes presented in this report cannot be considered as one-to-one trading volumes possibly affected under any future regulation. However, they do provide a comprehensive framework for further discussion.

Data gaps

Data gaps and exemptions might occur in some cases, e.g. due to missing conversion factors or missing trade data in kg for individual products. In both cases RWE m³ values have not been determined. Missing trade volume data sometimes is related to supplementary units of reporting, such as e.g. cubic meter or vessels. In some of these cases, also no conversion factors were available. For other products reported trade quantities are incomplete, as individual countries did not report quantities to the trade statistics. In these cases, we made a rough estimate for the missing quantities (which we report in the Annex Table 1), but did not correct the data. In most cases, these data deviations are minor.

Due to missing data for individual products the aggregated values (on 2-digit and 4-digit level) reported in the results tables in Chapter 3 partly underestimate the actual total RWE volume. However, we assume these are minor discrepancies in terms of volume, since the products with missing RWE conversion factors contain rather small amounts of wood.

Bamboo and rattan

Some products contain (partially) bamboo and/or rattan. Bamboo and rattan are partly comparable to wood, but products made from these raw materials cannot be directly described as wood-based products. Conversion factors to roundwood equivalents are therefore not available. The RWE value for products containing only bamboo and rattan is therefore not provided (see Annex for a list of affected products). However, some bamboo and rattan products may contain portions of wood as well. For these products it is estimated, that 5 % of the traded quantity contains wood. For this portion the RWE conversion factor of a corresponding wood-based product is assumed.

Products with uncertain wood content

The greatest uncertainty in the application of RWE conversion factors is subject to products which can be made out of wood (can contain wood) but which are not always made out of wood (such as toys). For several products the wood content contained in the traded quantities is subject to great uncertainties and no recognized data

sources are available that can be used to calculate the wood content. Existing estimates sometimes provide estimate ranges, mismatch among each other, or are not comprehensible. We have therefore decided to review the factors for each individual product with uncertain wood content through our own (authors) expert judgment and expertise from other experts of the Thünen Institute and adjust them as necessary. A detailed description of the procedure is given in Chapter 2.3. The adjusted estimates applied, represent the best available data source to our knowledge. However, as no cross-check of the data is possible, the calculated RWE volumes of these products are still subject to uncertainties.

All products at the 8-digit level that are covered by this working paper are listed in Annex Table 1. With each product code, the EUTR-scope, the RWE conversion factor (if available), and the data source for the conversion factor are displayed. The data source is either TI – referring to conversion factors calculated and applied by the Thünen Institute (TI-WF, 2022), or EC – referring to the impact assessment study of the European Commission (EC, 2019), or Ex – referring to own expert judgements made by the authors of this report and, where necessary, after discussion with other experts. Conversion factors given as zero indicate that the product does not contain wood. Conversion factors without any value indicate that no conversion factor for this product is available, respectively no data source is provided for these products.

The impact assessment study of the European Commission (EC, 2019) applies expert judgments about the wood content of products with uncertain wood content (see Chapter 2.3). According to this data source the wood content is marked in column wood content category as: n - negligible wood content, m - may contain wood, l - low wood content, or h - high to medium wood content. This wood content category is only indicated in Annex Table 1 if it was applied in the calculations. All products with the data sources given as EC, therefore additionally report the applied wood content category. For these products the estimates of the wood content share of the traded quantities are used before a conversion factor is applied.

For products where the underlying weights are incomplete, further comments are made (see column *incomplete* [%]). The figures in this column are given as 100 % if no weights at all are available for this product (e.g. if trade statistics report supplementary units as pieces of vessels, but no kg value is available). The column shows a percentage > 0 % and < 100 % if the underlying quantity data (in kg or supplementary units) in the trade statistics are incomplete. This is due to data gaps caused by missing reporting of quantity data by individual countries. The percentage value given in the table represents a rough estimate of the missing quantities, based on the reported import values of the respective goods (in Euro). Products labeled *bamboo* in this column are assumed to be made solely of bamboo and no admixture of wood fiber is expected.

For products falling under CN code 4403, the conversion factor to RWE m³ does not refer to the product weight in kg, but to the supplementary unit as reported by EUROSTAT.
